Minutes of the 2021 Ordinary General Meeting

### 1. Obituary

In 2020, 149 beneficiaries of the Pension Fund died, including 126 former staff members. Wherever possible, the GAC-EPA extends its sincere condolences to the families of the deceased. (the list of deaths can be consulted at any time).

#### 2. Results of the votes

Out of 1720 members, 205 persons returned their ballot paper in time. In addition, other ballots were returned but could not be counted as the postal voting procedure had not been followed.

### 3. Approval of the Minutes of the Ordinary General Meeting held on 20 February 2020

One vote AGAINST, three abstentions; the minutes of the 2020 AGM were approved.

## 4. Report on activities in 2020-2021 and presentation of the new Committee by the president of GAC-EPA

One vote AGAINST, one abstention; the Activity Report 2020-2021 as attached to the letter of 20 May 2021 was approved.

Dear GAC-EPA members,

first of all I would like to thank you for your support and loyalty to our association.

I would like to briefly recall the aims of our activity: to bring together pension fund beneficiaries, to defend their interests and to provide the necessary information.

All this is done through meetings, publication of the bulletin, permanence and especially participation in very important committees within CERN and ESO.

We have our own representative in the governing board of the pension fund, two delegates are members of the CHISB, a representative on the ESO health working group. We have seven representatives in the CERN Staff Council and we participate in the work of the its commissions D-1.35ms [109.213 deading with inter alia health insurance and pension fund matters.

The Governing Board of the Pension Fund has had a turbulent year, with tense exchanges on new possibilities of purchasing a surviving spouse's pension, the non-renewal of the administrator's contract, and the resignation of the PFGB Chairperson. But the Fund's investors saved a bad start to the year, with a negative return of nearly -4% at the end of March, by taking advantage of a turbulent market to reach +9.21% at the end of the year. Within the framework of the pension fund activity, it is worth noting that Michel Baboulaz has completed his six-year term of office.

On behalf of our Committee, I would like to thank him for the enormous commitment he has carried out with great competence and efficiency.

As of 1 April 2021, Philippe Charpentier will represent the pensioners. We are counting a great deal on his competence and commitment.

#### 4.2. Acquisition of a surviving spouse's pension.

Last year, the CERN Council approved the new possibilities to acquire a surviving spouse's pension for pensioners who have married since August 2006 or who will marry in the future. A long battle came thus to a successful end alas with a bitter taste on the health insurance arrangements for those concerned. In the discussions, the Staff Association and GAC-EPA have strongly opposed, for formal and substantive reasons, the decrease of CERN's health insurance contributions which alters and distorts the balance of the package of measures agreed for the pension part.

Unfortunately without success, because after arbitration by the Director General, the package of changes (Pension Fund and CHIS) were proposed to the CERN Council.

#### 4.3. CERN Health Insurance Scheme Board

Our presence and commitment has never been lacking in the activities of the CHISB, particularly in these extremely difficult times.

Regularly updated useful information about the COVID-19 pandemic can be found on the home page of CHIS: https://chis.cern and on https://hse.cern/covid-19-information. Keep yourselves informed! The strong recommendation is to get vaccinated in your country of residence as soon as possible, according to the rules in force there.

A particularly worrying possibility is that some members are voluntarily deferring diagnosis or treatment. We are all strongly discouraged to take this attitude. Such a delay may well aggravate conditions, leading to more difficult and expensive treatment afterwards.

The introduction of online reimbursement claims (myUNIQA) is judged to have been a good success, with more than 70% of claims being made this way by the end of 2020 with a reduced error rate.

#### 4.4. CSG-CRDS

As far as C2S is concerned, an extremely complex dossier has been successfully completed before the court in Bourg-en-Bresse.

CSG - CRDS liability, whether on assets or on the CERN pension, remains the main subject of the Commission's activity.

#### 4.4.1. CSG - CRDS on pensions:

For some time now, there has been an upsurge in the number of pensioners who have been "nabbed" by the Treasury for regularisation requests.

The latest events give a lot of hope, when it comes to obtaining the reimbursement of the sums requested.

#### 4.4.2. CSG -CRDS on assets:

#### 4.7. Pensioners' access to the CERN computing infrastructure

The CERN Task Force (in which we are not represented!) made some progress, but the intended implementation date of end-2020 was not met and pensioners will suffer another year of being cut-off from essential information like which regulations apply to access the CERN sites, our rights and obligations towards CERN etc.

I would like to point out, though, that our file is still having difficulty concluding, the first contact with the new Director of Administration Raphael Bello has been very constructive and positive. All this bodes well for a continued active dialogue, fundamental for the recognition of our presence within CERN.

You will find much more detailed information on these subjects in the spring 2021 GAC-EPA Bulletin.

All this thanks to the great commitment of our committee members.

#### 5.2. Balance sheet

On the liabilities side of the balance sheet, we have a "Transitional liability" of CHF 12'281.73, for the following reason. At the start of the year, we still have bills to pay for the year we are closing. In this case, we have paid invoices received in 2021, but for 2020 corresponding to the above amount.

The annual membership fee will remain CHF. 30.00.
